¹ After the entry into force of the Agreement Switzerland intends to amend Section II-D of Appendices 1, 4, 5, 6 and 10 of this Annex in conformity with the coverage achieved under the World Trade Organisation's revised Government Procurement Agreement of 2012, that has entered into force for Switzerland on 1st January 2021, provided that the level of coverage comparable to that existing prior to the amendment is at least sustained in this Annex. Once the State Parties have agreed on such amendments, the Joint Committee shall adopt a decision containing these amendments in accordance with Article 14 (Joint Committee) of the Agreement.

APPENDIX 8 TO ANNEX XVIII

TIME PERIODS

General Minimum Time Limit

1. A procuring entity that uses selective tendering shall establish that the final date for the submission of requests for participation shall not, in principle, be less than 25 days from the date of publication of the notice of intended procurement. Where a state of urgency duly substantiated by the procuring entity renders this time period impractical, the time period may be reduced to not less than ten days.
2. Except as provided for in paragraphs 3 and 4, a procuring entity shall establish that the final date for submission of tenders shall not be less than 40 days from the date on which:
 - (a) in case of open tendering, the notice of intended procurement is published;
or
 - (b) in the case of selective tendering, the entity notifies suppliers that they will be invited to submit tenders.

Possibilities for Reducing the General Time Limits

3. A procuring entity may reduce the time period for tendering established in accordance with paragraph 2 by five days for each one of the following circumstances:
 - (a) the notice of intended procurement is published by electronic means;
 - (b) all the tender documentation is made available by electronic means from the date of the publication of the notice of intended procurement; and
 - (c) the entity accepts tenders by electronic means.
4. Under the following circumstances, entities may establish a time period for tendering that is shorter than the periods referred to in paragraph 2, provided that such time period is sufficiently long to enable suppliers to prepare and submit responsive tenders and is in no case less than ten days prior to the final date for the submission of tenders:
 - (a) where a notice of planned procurement has been published at least 40 days and not more than 12 months in advance of the publication of the notice of intended procurement and the notice of planned procurement contains:
 - (i) a description of the procurement;
 - (ii) the planned dates for the submission of requests for participation or tenders;

- (iii) the address, if possible the electronic address, from which documents relating to the procurement may be obtained; and
 - (iv) as much of the information that is required according to paragraph 3 of Article 11.12 (Notices) of the Agreement, as is available at the time of the publication of the notice;
- (b) where the procuring entity, for recurring contracts, indicates in an initial notice of intended procurement that subsequent notices will provide time limits for tendering based on this paragraph; and
- (c) where a state of urgency duly substantiated by the procuring entity renders the periods specified in paragraph 2 impracticable.

5. The use of paragraph 3, in conjunction with paragraph 4, shall in no case result in the reduction of the time period for tendering set out in paragraph 2 to less than ten days prior to the final date for the submission of tenders.

6. Where a procuring entity purchases commercial goods or services, or any combination thereof, it may reduce the time period for tendering established in accordance with paragraph 2 to not less than 13 days, provided that it publishes by electronic means, at the same time, both the notice of intended procurement and the tender documentation. In addition, where the entity accepts tenders for commercial goods or services by electronic means, it may reduce the time period established in accordance with paragraph 2 to not less than ten days.

7. Where a procuring entity covered under Appendices 2 or 3 has selected all or a limited number of qualified suppliers, the time period for tendering may be fixed by mutual agreement between the procuring entity and the selected suppliers. In the absence of an agreement, the time period shall not be less than ten days.

APPENDIX 9 TO ANNEX XVIII
THRESHOLDS ADJUSTMENT FORMULA

SECTION I

MERCOSUR

Each MERCOSUR State shall calculate and convert the value of the thresholds into its respective national currency, using the conversion rates of the IMF. The conversion rates will be the average of the values of their respective national currencies in terms of the SDR published by the IMF in its monthly “International Financial Statistics”, over the two-year period preceding 1 October or 1 November of the year prior to the thresholds becoming effective. The converted thresholds shall apply from 1 January of the following year and will be fixed for one year.

The value of the newly calculated thresholds shall be made available, in its respective currency, by each MERCOSUR State, before the respective thresholds take effect.

SECTION II

EFTA STATES

Each EFTA State shall calculate and convert the value of the thresholds into its own national currency using the conversion rates of its respective national bank. The conversion rates will be the average of the values of the respective national currency in terms of the SDR over the two-year period preceding 1 October or 1 November of the year prior to the thresholds becoming effective. The conversion rate shall apply from 1 January of the following year and will be fixed for two years.

The value of the newly calculated thresholds shall be made available, in its respective currency, by each EFTA State, before the respective thresholds take effect.

APPENDIX 10 TO ANNEX XVIII

ADDITIONAL NOTES

SECTION I

MERCOSUR

A. Argentina

The following general notes apply to all procurement covered by Chapter 11 (Government Procurement).

1. Chapter 11 (Government Procurement) of the Agreement shall not apply to public procurement programmes aimed at favouring MSMEs through price preferences, the right to improve the original tender offer and comparative advantages, in accordance with Argentina's domestic laws and regulations. For greater certainty, access to such programmes is available to MSMEs from the EFTA States, provided they meet the requirements set out in Argentina's domestic laws and regulations, including registration as MSMEs in Argentina. Argentina, including its procuring entities, shall accord MSMEs from the EFTA States treatment no less favourable than the treatment it accords to MSMEs of any non-Party.
2. Chapter 11 (Government Procurement) of the Agreement shall not apply to pre-commercial government procurement aimed at promoting the development of innovative solutions for public sector needs. Pre-commercial government procurement includes the product idea, solution design, prototyping, original development and validation or testing of a limited set of first products
3. Chapter 11 (Government Procurement) of the Agreement shall not apply to public concessions, such as public services concessions and public work concessions.
4. Notwithstanding paragraph 2 of Article 11.13 (Conditions for Participation) of the Agreement, Argentina may exclude a supplier if:
 - (a) there is a confirmed indictment against the supplier for crimes against property, or against the public administration, or against public faith, or against the economic and financial order, or for crimes set forth in the Inter-American Convention against Corruption; or
 - (b) the supplier is:
 - (i) an agent or official of Argentina's public sector; or
 - (ii) an enterprise in which such agent or official has sufficient participation so as to control the company's decision-making process.

5. Argentina reserves the possibility to award contracts by means other than open or selective tendering procedures:

- (a) in case of a procurement undertaken for the repair of machinery, vehicles, equipment or engines whose disarmament, transfer or prior examination is essential to determine the necessary repair and the adoption of another contracting procedure proves to be more expensive. This exception may not be used for common maintenance repairs of such items.
- (b) for complementary works that are essential for the execution of an ongoing public work (construction services), which could not have been foreseen in the original project nor could have been included in the respective contract. The value of contracts awarded for the complementary works shall not exceed the limits set forth in Argentina's domestic laws and regulations, which shall in no case exceed 50% of the value of the main contract.

6. Chapter 11 (Government Procurement) of the Agreement shall not apply to government procurement carried out outside Argentina, for consumption outside its territory.

7. Notwithstanding Article 11.10 (Offsets) of the Agreement, if the entities listed in Section I-A of Appendix 1 carry out government procurement covered by Chapter 11 (Government Procurement) of the Agreement, Argentina may seek or impose, in accordance with its domestic laws and regulations, any type of offset for up to 50% of the value of the procurement, including that the awarded supplier purchases local goods and services related to the object of the procurement.

From the 11th year from the entry into force of the Agreement, Argentina may only seek or impose offsets for up to 35% of the value of the procurement.

The limitations set forth in the paragraphs above shall not apply to procurements undertaken by the Ministerio de Seguridad Nacional and Ministerio de Defensa.

Offsets shall be indicated in the notice of intended procurement or in the tender documentation and must be clearly defined in the tender documentation.

From the 16th year from the entry into force of the Agreement, Argentina shall not seek or impose offsets to any covered procurement.

8. Chapter 11 (Government Procurement) of the Agreement shall not apply to public procurement undertaken among public entities, whether they are included or not in the respective Sections I-A of Appendices 1 to 3.

9. Notwithstanding subparagraph 1(a) of Article 11.12 (Notices) of the Agreement, Argentina may apply a transitional period of up to 24 months from the date of the entry into force of the Agreement. Three months from the entry into force of the Agreement, the entities listed in Section I-A of Appendix 1 shall, at minimum, provide their notices of intended procurement through links in a gateway electronic site that is accessible free of charge during such transitional period.

B. Brazil

The following general notes apply to all procurement covered by Chapter 11 (Government Procurement).

1. Chapter 11 (Government Procurement) of the Agreement shall not apply to:
 - (a) procurement conducted between public entities;
 - (b) procurement made outside the territory of Brazil, for consumption outside its territory;
 - (c) contracting related to the delegation of services, such as authorizations, permits and concessions, except the concession of works which are covered under Works Concessions of Section I-B of Appendix 6;
 - (d) public procurement of goods and services purchased under food and nutritional security and school feeding programs that support family farmers or family farming cooperatives carrying specific registration, according to domestic laws and regulations; or
 - (e) procurement related to the Unified Health System (Sistema Único de Saúde - SUS).
2. The prohibition of offsets outlined in Article 11.10 (Offsets) shall not apply to Brazil if the conditions and their assessment are non-discriminatory among potential tenderers, clearly defined in the procurement documents and indicated in the notice of intended procurement.
3. Brazil reserves the right to apply margins of preference to national manufactured goods and services as established in the federal Brazilian legislation. The EFTA States shall be informed within 30 days from the government taking a decision regarding goods and services that may fall under this category.
4. Brazil reserves the right to apply margins of preference in prices, as well as set-aside policies of up to 25 % of the procurement object, in favour of its micro and small enterprises⁹
5. Brazil reserves the right to conduct a limited tendering procedure in procuring goods and services from non-profit Brazilian institutions dedicated to social assistance, public services, or social services of public interest.
6. In addition to the possibility to conduct limited tendering for pre-commercial government procurement aimed at promoting the development of innovative solutions for

public sector needs set forth in subparagraph (f) of Article 11.22 (Limited Tendering) of the Agreement, Brazil may, whenever this provision has been invoked, use limited tendering for subsequent purchases of the same goods and services that have been developed under such arrangement from the national developer of the prototype or first good or service .

7. Without prejudice to the overall balance of Chapter 11 (Government Procurement), the State Parties may, by mutual agreement and on a case-by-case basis, explore the possibility of reviewing elements of this Appendix, provided that such review does not affect the policy instruments enshrined herein.

C. Paraguay

Note on the application of Annex XVIII (Government Procurement) between the EFTA States and Paraguay

The application of Annex XVIII (Government Procurement) shall be subject to receipt by the EFTA States within three years from the entry into force of the Agreement of a written notification by Paraguay stating the consent of Paraguay to apply Annex XVIII (Government Procurement).

General notes

1. In national public tenders called by entities covered in Section I-C of Appendix 1, Paraguay reserves the right to apply support programmes for national production and employment referring to contracts Paraguay makes. With regard to support programmes for production and national employment, Paraguay may:

- (a) apply a margin of price preferences of 20%, to goods and services of national origin:
 - (i) to goods, if labour, raw materials and inputs from Paraguay represent a percentage equal to or greater than 40%;
 - (ii) to road works, constructions, maintenance services, transportation, insurance, consulting and others in general when the nationality of the staff of the provider is more than 70% Paraguayan.

This shall apply for 20 years from the entry into force of the Agreement.

- (b) use support programs to stimulate national development, innovation, scientific and technological research, including offsets provided that their conditions and their assessment are non-discriminatory and it is indicated in the notice of intended procurement as well as clearly defined in the procurement documents.

This shall apply for 15 years from the entry into force of the Agreement.

2. The coverage of the Agreement shall be defined by a negative list of goods, a positive list of services and a list of governmental entities at central level.

3. Chapter 11 (Government Procurement) of the Agreement shall not apply if the subject matter of a bidding refers to domestic policies aimed at: education, health, food and nutritional security and school feeding programmes, and family farming programmes, provided for in the domestic laws and regulations.

4. Chapter 11 (Government Procurement) of the Agreement shall not apply to:

- (a) purchases of Paraguayan state owned companies and any other public institution not listed in Section I-C of Appendices 1 and 2;
- (b) contracts for the delegation of services, such as authorisations, permits and concessions, including the concession of public works;
- (c) non-contractual agreements or any form of assistance provided by Paraguay or Paraguayan state enterprise, including contracting under programmes financed with loans from international financial organisations, donations, capital increases, tax incentives, subsidies, guarantees, agreements cooperation, public provision of goods and services, to people or governments at the regional, province or local level;
- (d) contracts signed for the sole purpose of rendering foreign assistance;
- (e) public procurement made outside of Paraguay, for consumption outside of Paraguay;
- (f) the acquisition of services of agencies or services of tax warehouses, services of liquidation and administration for regulated financial institutions, nor the services of sale and distribution of public debt; and
- (g) public procurement undertaken among public entities, whether or not in Section I-C of the Appendices.

D. Uruguay

1. Chapter 11 (Government Procurement) of the Agreement shall not apply to:

- (a) procurements of crude oil and its derivatives, basic oils, lubricant additives and their respective freight rates;
- (b) energy procurements;
- (c) procurements of livestock by selection, in the case of specimens with special characteristics;
- (d) hiring financial services;
- (e) contracts of delegation of services, such as authorisations, permits and concessions, include concessions of construction services; and

- (f) procurement under the Public Procurement for Development Programme in accordance with decree TOCAF 2012 N° 150/012 and its amendments and the Law on Family Farming and Artisanal Fishing.
2. Notwithstanding Chapter 11 (Government Procurement) of the Agreement, in construction services contracts or public works, Uruguay may grant a margin of preference in the price of the offers, which may be conditioned to hiring nationals, in accordance with the requirements of qualification established in Uruguayan laws and regulation
3. Chapter 11 (Government Procurement) of the Agreement shall not apply to:
- (a) procurements financed by donations, loans or other forms of international assistance, if the delivery of such assistance is subject to conditions incompatible with the Agreement;
 - (b) public procurements made from an entity to another entity or to an Uruguayan state enterprise, whether or not listed in Section I-D of Appendices 1, 2 or 3; and
 - (c) public procurements made outside Uruguay, for consumption outside Uruguay.
4. Notwithstanding Chapter 11 (Government Procurement) of the Agreement, Uruguay may reserve in each year, purchase contracts subject to the Agreement for an amount equivalent to 15% of its total purchases of the previous year, with the object of promoting specific plans of promotion of some sector or activity, founded on public policies and instrumented in rules that specify their content and scope.

From the 15th year from the entry into force of the Agreement, the percentage of 15% shall be reduced to 5% of its total purchases of the previous year.

5. Entities may award contracts by other means than the open tender procedures, in any of the following circumstances:
- (a) in the case of construction services or public works if construction services additional to those originally contracted are required, that respond to unforeseen circumstances and that are necessary for the fulfilment of the objectives of the contract that originated them. However, the total value of the contracts awarded for such additional construction or public works services may not exceed 50% of the amount of the main contract;
 - (b) to additional deliveries by the original supplier that are intended to be used as spare parts, extensions or continuity of existing equipment service, computer programs, services or existing facilities, if the change of supplier would force the entity to purchase goods or services that do not meet the requirements for compatibility with the equipment, computer programmes, services or existing facilities; or
 - (c) if an entity requires consulting services related to aspects of a confidential nature, whose dissemination could reasonably be expected to compromise confidential information of the public sector, cause serious economic disturbances or, similarly, be contrary to the public interest.

SECTION II

EFTA STATES

A. Iceland

Note on the application of Annex XVIII (Government Procurement) between Iceland and Paraguay.

Annex XVIII (Government Procurement) shall only be applied to goods, services, providers and suppliers from Paraguay from the first day of the second month following the date of the receipt of notification according to Paraguay's "Note on the application of Annex XVIII (Government Procurement) between the EFTA States and Paraguay" set out in Section I-C of Appendix 10 and subsequent application by Paraguay.

Absent the receipt of a written notification from Paraguay in line with its "Note on the application of Annex XVIII (Government Procurement) between the EFTA States and Paraguay", the market access offer by Iceland in Annex XVIII (Government Procurement) shall towards Paraguay be deemed as withdrawn.

General notes

Chapter 11 (Government Procurement) of the Agreement shall not apply to:

- (a) contracts for the acquisition, development, production or co-production of programme material by broadcasters and contracts for broadcasting time;
- (b) contracts awarded to an entity which is itself a contracting authority within the meaning of the Public Procurement Act (Lög um opinber innkaup (120/2016)) on the basis of an exclusive right which it enjoys pursuant to domestic laws and regulations;
- (c) procurement of agricultural products made in furtherance of agricultural support programmes and human feeding programmes; or
- (d) procurement by procuring entities covered under Section II-A of Appendices 1 and 2 in connection with activities in the fields of drinking water, energy, transport, telecommunications and the postal sector unless covered under Section II-A of Appendix 3

B. Liechtenstein

Note on the application of Annex XVIII (Government Procurement) between Liechtenstein and Paraguay.

Annex XVIII (Government Procurement) shall only be applied to goods, services, providers and suppliers from Paraguay from the first day of the second month following the date of the receipt of notification according to Paraguay's "Note on the application of Annex XVIII

(Government Procurement) between the EFTA States and Paraguay” set out in Section I-C of Appendix 10 and subsequent application by Paraguay.

Absent the receipt of a written notification from Paraguay in line with its “Note on the application of Annex XVIII (Government Procurement) between the EFTA States and Paraguay”, the market access offer by Liechtenstein in Annex XVIII (Government Procurement) shall towards Paraguay be deemed as withdrawn.

General notes

1. Chapter 11 (Government Procurement) of the Agreement shall not apply to:
 - (a) procurement of agricultural products made in furtherance of agricultural support programmes and human feeding programmes;
 - (b) the acquisition, development, production or co-production of programme material by broadcasters and contracts for broadcasting time;
 - (c) procurement by procuring entities covered under Section II-B of Appendices 1 and 2 in connection with activities in the fields of drinking water, energy, and transport sector; unless covered by Section II-B of Appendix 3; or
 - (d) fund placements of insured persons conducted by public entities or undertakings such as public insurance and pension’s funds.
2. The provision of services, including construction services, in the context of procurement procedures according to Chapter 11 (Government Procurement) of the Agreement is subject to the conditions and qualifications for market access and national treatment as required by Liechtenstein in conformity with its commitments under GATS and Chapter 8 (Services) of the Agreement.

C. Norway

Note on the application of Annex XVIII (Government Procurement) between Norway and Paraguay.

Annex XVIII (Government Procurement) shall only be applied to goods, services, providers and suppliers from Paraguay from the first day of the second month following the date of the receipt of notification according to Paraguay’s “Note on the application of Annex XVIII (Government Procurement) between the EFTA States and Paraguay” set out in Section I-C of Appendix 10 and subsequent application by Paraguay.

Absent the receipt of a written notification from Paraguay in line with its “Note on the application of Annex XVIII (Government Procurement) between the EFTA States and Paraguay”, the market access offer by Norway in Annex XVIII (Government Procurement) shall towards Paraguay be deemed as withdrawn.

General notes

1. Chapter 11 (Government Procurement) of the Agreement shall not apply to:
 - (a) procurement for the acquisition, development, production or co-production of programme material by broadcasters and contracts for broadcasting time;
 - (b) procurement of agricultural products made in furtherance of agricultural support programmes and human feeding programmes.
 - (c) procurement by procuring entities covered under Section II-C of Appendices 1 and 2 in connection with activities in the fields of drinking water, energy, transport and the postal sector, unless covered under Section II-C of Appendix 3.

D. Switzerland

Note on the application of Annex XVIII (Government Procurement) between Switzerland and Paraguay.

Annex XVIII (Government Procurement) shall only be applied to goods, services, providers and suppliers from Paraguay from the first day of the second month following the date of the receipt of notification according to Paraguay's "Note on the application of Annex XVIII (Government Procurement) between the EFTA States and Paraguay" set out in Section I-C of Appendix 10 and subsequent application by Paraguay.

Absent the receipt of a written notification from Paraguay in line with its "Note on the application of Annex XVIII (Government Procurement) between the EFTA States and Paraguay", the market access offer by Switzerland in Annex XVIII (Government Procurement) shall towards Paraguay be deemed as withdrawn.

General notes

1. Chapter 11 (Government Procurement) of the Agreement shall not apply to:
 - (a) procurements of goods and services carried out inside a procuring entity or to procurements of goods or services obtained or acquired by a procuring entity from another procuring entity with legal personality (inhouse);
 - (b) procurement of agricultural products made in furtherance of agricultural support programmes and human feeding programmes.
 - (c) procurement of goods and services which can only be acquired from organisations with special or exclusive rights granted as result of published legislative, regulatory or administrative provisions (e.g. for the purchase of drinking water or energy); or
 - (d) to the funding of placements of funds of insured persons conducted by public organisations such as public insurance and pension funds.

2. The provision of services, including construction services, in the context of procurement procedures according to Chapter 11 (Government Procurement) of the Agreement shall be subject to the conditions and qualifications for market access and national treatment as required by Switzerland in conformity with its commitments under GATS and Chapter 8 (Trade in Services) of the Agreement.

3. Regardless of their activities, centralised and decentralised administrative authorities and entities are only subject to Section II-D of Appendices 1 and 2. Regardless of the activities, public authorities or public undertakings under Section II-D of Appendix 3 are not subject to respective Sections II-D of Appendices 1 and 2.
